# A. Clubhouse pipe burst

- i. Chris stated that the proposal for repair is out. They do not know how deep the pipe is that has burst. There are significant variables in terms of cost. Quote is for \$2,681.

    - Rich seconds the motion

### B. Pond Issues

  - 1. Beaver activity is being addressed. Two have been caught, continuing to monitor.
  - 2. Pool maintenance company will clear the drain
- ii. New pond warning signs
  - 1. Chris made new warning signs for the ponds. Rich will replace old signs.

### C. Pool issues

- i. Pool opening
  - 1. Pool opening may need to be delayed for repair of water supply. Pool is scheduled to be open May 11th, but will be dependent on the inspection on the 8th.
  - 2. Board to send a message to the neighborhood regarding potential for delay for pool opening.
- ii. Pumphouse vandalism
  - 1. Rich and Fred repairing the vandalism written on the pumphouse
  - 2. Fred reported to Cary PD

# D. Cary PD Neighborhood Monitoring
